

DIRECTION NOTICE: RESTRICTION OF PUBLIC ACCESS UNDER THE COUNTRYSIDE AND RIGHTS OF WAY ACT 2000

The relevant authority Natural England gives this direction for the purposes of land management and public safety under section 24 and 25(1)(b) of the Countryside and Rights of Way (CROW) Act 2000 to give effect to the exclusion or restriction detailed below.

This direction is to be read in conjunction with the separate site notice bearing the case number below.

Case number: 2016048135

Site name: Wilton 3 Quarry

Date of issue: September 8th 2016

Expiry date: September 7th 2027

Period of restriction/exclusion

Access will be excluded in the way described below on a Wednesday, Friday and Sunday from dawn to dusk all year.

Nature of restriction

Public access by virtue of section 2(1) of CROW to the land detailed below is to keep people to marked routes.

Land affected

The site notice which accompanies this direction shows the land affected by this exclusion in red hatching and the route to which the access rights are confined.

Reason why this direction has been given:

The relevant authority Natural England is satisfied that exclusion of the access rights to the extent specified is necessary for the purpose of preventing disruption to the shooting activities and to ensure public safety.

Information and conditions which apply to this direction

1. This direction only affects the availability of public access rights conferred by virtue of section 2(1) of CROW. It has no effect on public rights of way over the same land, or on existing open access rights of the type listed at CROW section 15, or on any other access right, tradition or custom, or any uses of the land permitted or tolerated by the landowner.
2. It has no effect on any area within the specified land that is not otherwise subject to the access rights described above – for example it has no effect on land which is excepted under Schedule 1 to CROW.
3. If, for any reason after the giving of this direction, the exclusion is no longer necessary for the purpose specified or no longer necessary to the extent (or at any of the times) specified under the direction, a representative of Bolton Gun Club should immediately notify the Open Access Contact Centre. The direction will then be revoked or varied as appropriate in the circumstances.

Revocation or variation of direction

4. Natural England may revoke or vary this direction by giving a further direction at a later date, if it considers this necessary.

Review of direction

5. Natural England will review the need for this direction within five years of the date of issue shown at the top of this notice and, subsequently, within five years of the date of the last review, until the direction is revoked or expires, as required by CROW section 27(3).

Date of issue: September 8th 2016

Expiry date: September 7th 2027

Period of restriction/exclusion

Access may be excluded in the way described below on a Monday, Tuesday, Thursday and Saturday, **only** when the range is in use.

The exact dates and times during which access is to be excluded are to be determined by a representative of Bolton Gun Club.

Exclusions must be notified to Natural England by the person specified above, by following the instructions given in the conditions below.

Nature of restriction

Public access by virtue of section 2(1) of CROW to the land detailed below is to keep people to marked routes.

Land affected

The site notice which accompanies this direction shows the land affected by this exclusion in red hatching and the route to which the access rights are confined.

Reason why this direction has been given:

The relevant authority Natural England is satisfied that exclusion of the access rights to the extent specified is necessary for the purpose of preventing disruption to the shooting activities and to ensure public safety.

Information and conditions which apply to this direction

1. This direction only affects the availability of public access rights conferred by virtue of section 2(1) of CROW. It has no effect on public rights of way over the same land, or on existing open access rights of the type listed at CROW section 15, or on any other access right, tradition or custom, or any uses of the land permitted or tolerated by the landowner.
2. It has no effect on any area within the specified land that is not otherwise subject to the access rights described above – for example it has no effect on land which is excepted under Schedule 1 to CROW.
3. The Open Access Contact Centre must receive notifications from Bolton Gun Club at least **one hour** before the restriction is to begin. Notifications may be made by email or by telephone.
4. If, for any reason after the giving of this direction, the exclusion is no longer necessary for the purpose specified or no longer necessary to the extent (or at any of the times) specified under the direction, a representative of Bolton Gun Club should immediately

notify the Open Access Contact Centre. The direction will then be revoked or varied as appropriate in the circumstances.

5. Red flags must be flying when this direction is in effect in accordance with the shooting club's Health and Safety responsibilities.

Revocation or variation of direction

6. Natural England may revoke or vary this direction by giving a further direction at a later date, if it considers this necessary.

Review of direction

7. Natural England will review the need for this direction within five years of the date of issue shown at the top of this notice and, subsequently, within five years of the date of the last review, until the direction is revoked or expires, as required by CROW section 27(3).

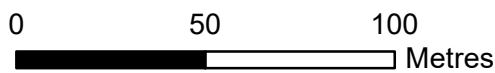
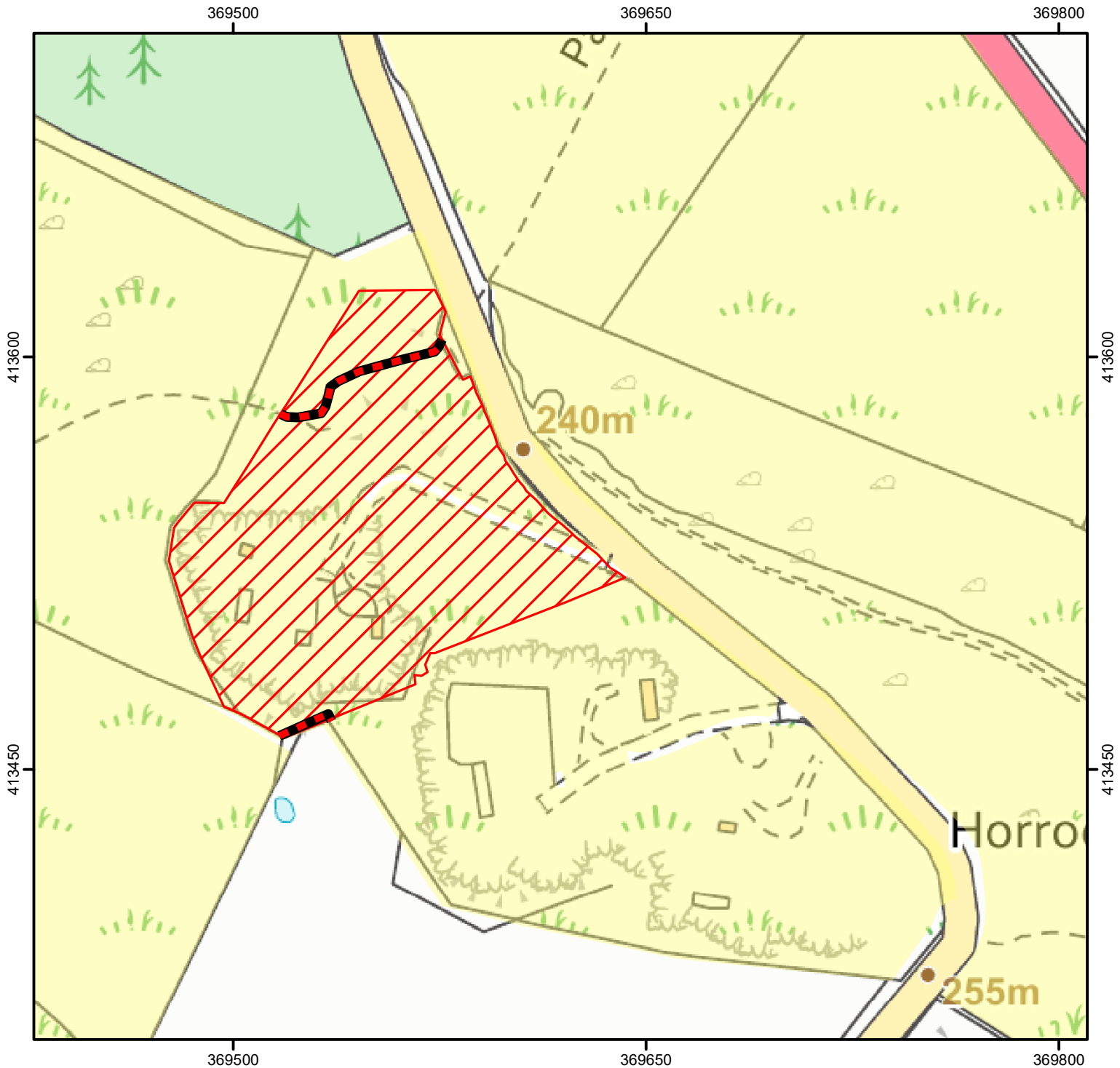
