RATEABLE VALUE

The Valuation Office Agency (VOA) is responsible for calculating the rateable value of your property. Bolton Council uses the rateable value to calculate your business rates bill. The current rateable value is shown on the front of your bill.

RETAIL, HOSPITALITY AND LEISURE RELIEF 2025/26

At the Autumn Budget the Chancellor announced Retail, Hospitality and Leisure (RHL) relief scheme will be extended for one year for 2025/26, retaining the existing eligibility criteria but reducing the level of relief to 40%, up to a cap of £110,000 per business.

Ratepayers will be eligible if they occupy premises that are wholly or mainly being used as:

- i. shops, restaurants, cafes, drinking establishments, cinemas or live music venues
- ii. for assembly and leisure; or
- iii. as hotels, guest & boarding premises or self-catering accommodation

Where an award was made in 2024/25 this will be carried forward. However, if you did not receive the discount in 2024/25 and wish to apply you will need to **complete the online Retail**, **Hospitality & Leisure Relief form at <u>www.bolton.gov.uk/business-rates/business-rates-reductions</u> (click on the Retail, Hospitality & Leisure Relief heading).**

SMALL BUSINESS RATE RELIEF (SBRR)

If your business occupies only one business property and the rateable value of the property in occupation is below £15,000 you will be eligible for SBRR (if you occupy more than one property you may still be eligible on the 'main' one if the rateable value of the others is low enough). If you qualify and the rateable value of your only (or main) property is £12,000 and

under the relief is 100%. If the rateable value is between £12,000 and £15,000 the percentage relief reduces on a sliding scale.

SUPPORTING SMALL BUSINESS RELIEF (SSB)

The 2023 Supporting Small Business (SSB) scheme will cap bill increases at £600 per year for any business losing eligibility for some or all Small Business Rate Relief at the 2023 revaluation. The relief will be awarded automatically to eligible businesses and you do not need to apply for it.

CHARITABLE RATE RELIEF

From April 2025, charitable rate relief will no longer be applicable to private schools. Amended bills will be issued once the relevant legislation has been passed.
