**THE BOROUGH COUNCIL OF BOLTON (PUBLIC FOOTPATH NO. 068 HORWICH  
(PART)) PUBLIC PATH EXTINGUISHMENT AND DEFINITIVE MAP AND STATEMENT  
MODIFICATION ORDER 2018**

This Order is made by the Borough Council of Bolton ("the authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the public footpath is not needed for public use.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the definitive map and statement of the Public Rights of Way for the Borough Council of Bolton require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the extinguishment (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Horwich Town Council has been consulted and has consented to the making of the Order as required by Section 120(2) of the 1980 Act;

**BY THIS ORDER**

1. The public right of way over the land situated within the vicinity of the properties known as Higher Wilson Fold Farm and Joli Brook Barn, High Rid Lane, Lostock, Bolton, BL6 4LH and shown by a continuous bold line on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be extinguished after 21 days from the date of confirmation of this Order and thereupon the definitive map of the Authority shall be modified by deleting from it that public right of way.
2. The definitive statement of the Public Rights of Way for the Authority shall be modified as described in Part 2 of the Schedule to this Order.
3. Notwithstanding this order, all statutory undertakers shall continue to have existing rights of access to and egress from any apparatus, equipment and plant accessible over the land referred to in Part 1 of the Schedule.

### PART 1

#### DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Public Footpath No 068 Horwich situated within the vicinity of the properties known as Higher Wilson Fold Farm and Joli Brook Barn, High Rid Lane, Lostock, Bolton, BL6 4LH commencing from the junction with public footpath Horwich 069 point A at grid reference SD366085 410371 in a generally north easterly direction to its junction with public footpath Horwich 187 point B at grid reference SD366132 410416 as shown by the continuous bold line between points A-B on the Order Plan over a total distance of approximately 66 metres and at a whole width of 1.5 metres throughout.

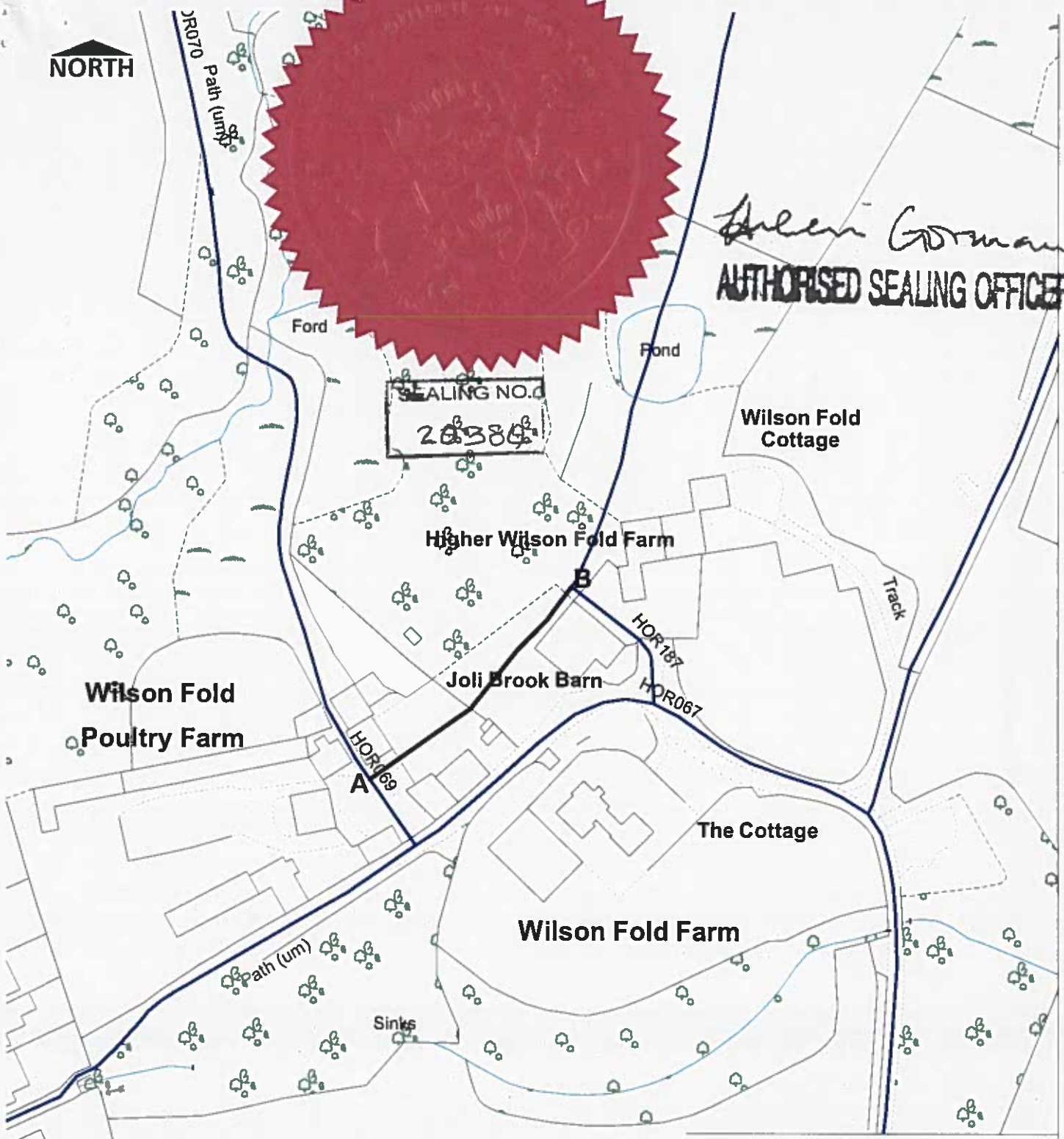
