**THE BOROUGH COUNCIL OF BOLTON (PUBLIC FOOTPATH NO. 231 BOLTON (PART))
PUBLIC PATH DIVERSION ORDER AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER 2021**

This Order is made by the Borough Council of Bolton ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act"). It appears to the Authority that in the interests the owner of the land crossed by the footpath described in paragraph 1 of this Order that it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that the Definitive Map and Statement of the Public Rights of Way for the Borough Council of Bolton require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

BY THIS ORDER:

1. The public right of way over the land which is situated to the south of Inverbeg Drive, Bolton, BL2 6NA and shown by a bold black continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up as from the date the Authority certifies that all necessary works to bring the footpath described in Part 2 of the schedule into a fit condition for use have been completed and thereupon the Borough Council of Bolton definitive map shall be modified by deleting from it that public right of way.
2. Notwithstanding this Order all statutory undertakers shall continue to have existing rights of access to and egress from any apparatus equipment and plant accessible over the land referred to in Part 1 of the Schedule.
3. There shall at the end of 21 days from the date of confirmation of this Order be a footpath over the land situated to the south of Inverbeg Drive, Bolton, BL2 6NA, described in Part 2 of the Schedule and shown by a bold black broken line on the map contained in this Order, and thereupon the Borough Council of Bolton definitive map shall be modified by adding that path to it.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.
5. The Definitive Statement of the Public Rights of Way for the Borough Council of Bolton shall be modified as described in Part 4 of the Schedule,

Part 1

Description of site of existing path or way

Public Footpath No. Bolton 231 situated to the south of Inverbeg Drive, Bolton, BL2 6NA commencing from point A at grid reference SD 375045 408998 in a generally east by southerly direction to point B at grid reference SD375090 408989 for a distance of approximately 47 metres as shown by the continuous bold black line between points A-B on the Order Plan of a width of 1.5 metres throughout over a natural surface.

Part 2

Description of site of new path or way

Public Footpath No. Bolton 231 commencing from a new line from point C at grid reference SD375092 408984 curving in a generally west-north westerly direction to point D at grid reference SD375088 408986 for a distance of approximately 5 metres then running in a generally west by northerly direction to point E at grid reference SD375067 408990 for a distance approximately 21 metres then running in a generally westerly direction to point F at grid reference SD375054 408990 for a distance of approximately 13 metres then curving in a generally north-north westerly direction to point A at grid reference SD375045 408998 for a distance of approximately 13 metres as shown by the bold black broken line between points C-D-E-F-A on the order plan over a total distance of approximately 52 metres of a width of 2 metres throughout over a asphalt surface.

Variation of particulars of path or way

District: Bolton

Path/Way Number: Public Footpath Bolton 231

Amend the existing statement entry with the following: Replace "Starts in former Top o'th' Moss farmyard at junction of Path Number 234 and Path Number 235 and runs to East through meadow to squeezer stile after 119m. Ends at junction with Path Number 228 and Path Number 229 after further 45m." with "commencing from its junction with path Bolton 229 at grid reference SD375092 408984 curving in a generally west-north westerly direction to grid reference SD375088 408986 for a distance of approximately 5 metres then running in a generally west by northerly direction with palisade fence and

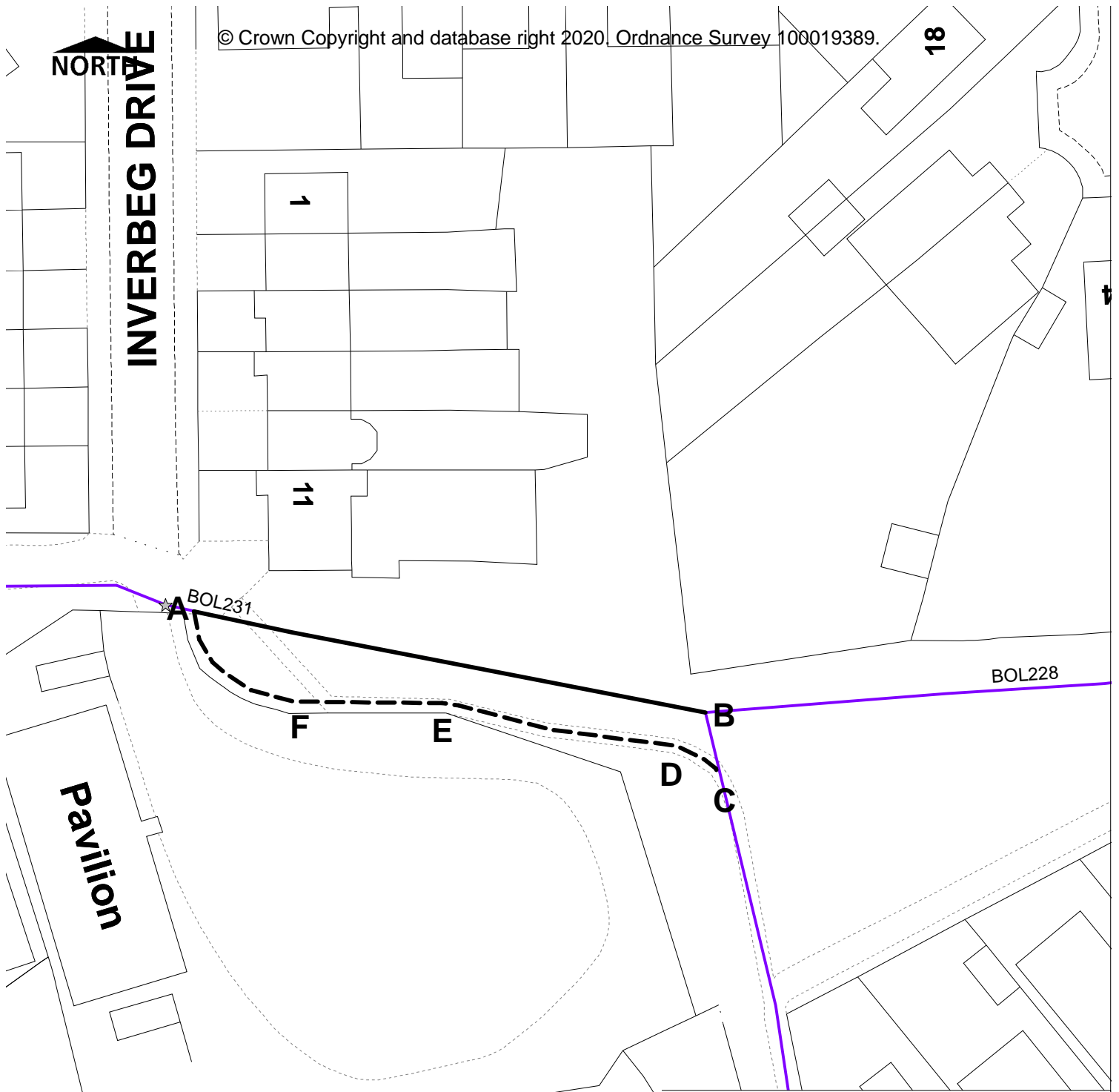
sports ground to the south to grid reference SD375067 408990 for a distance of approximately 21 meters then running in a generally westerly direction with palisade fence and sports ground to the south to grid reference SD375054 408990 for a distance of approximately 13 metres then curving in a generally north-north westerly direction with palisade fence and sports ground to the west to grid reference SD375045 408998 for a distance of approximately 13 metres then running in a generally west by northerly direction between garages and houses to meet the footway on Tarbet Drive at grid reference SD374975 409009 for a distance of approximately 72 metres then running in a generally west by southerly direction along the footway to its end adjacent to number 88 Tarbet Drive at grid reference SD374880 408998 for a distance of approximately 96 metres”

Total Length: 220 metres

Width: Between grid reference SD375092 408984 and SD375045 408998; 2.0 metres throughout. Between grid reference SD375045 408998 and SD374975 409009; 3.0 metres throughout. Between grid reference SD374975 409009 and SD374880 408998; 1.8 metres throughout.

Surface Type: Asphalt.
