## THE STOPPING UP OF HIGHWAY (NORTH WEST) (NO.57) ORDER 2024

The Secretary of State makes this Order in exercise of powers under section 247 of the Town and Country Planning Act 1990 ("the Act").

- 1. The Secretary of State authorises the stopping up of the highway described in the Schedule to this Order and shown on the plan numbered NATTRAN/NW/S247/5667, to enable development to be carried out in accordance with the planning permission granted by Bolton Council under reference 18253/24.
- 2. Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any highway authorised to be stopped up pursuant to this Order then, subject to section 261(4) of the Act, those undertakers shall have the same rights as respects that apparatus after that highway is stopped up as they had immediately beforehand.
- 3. This Order shall come into force on 12 November 2024.



# Description of highway to be stopped up

The highway to be stopped up is at Bolton in the Metropolitan Borough of Bolton, shown on the plan as a northern part width of Winterfield Drive. It commences from the south eastern boundary of No. 302 Hulton Lane and extends in a generally westerly direction for a maximum distance of 30 metres and has a maximum width of 4 metres.
