



THE BOLTON (REGULATION OF WAITING, LOADING AND UNLOADING) (CONSOLIDATION) ORDER 2015 AND THE BOLTON (SHORESWOOD AND BELMONT ROAD)(TEMPORARY WAITING RESTRICTIONS) (No.126) ORDER 2024 (ASTLEY BRIDGE WARD VARIOUS STREETS) (AMENDMENT) (NO.XX) ORDER 2025

The Borough Council of Bolton, in exercise of their powers under Sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Constable of Greater Manchester Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

- 1. The Interpretation Act 1978, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, means the Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, or as that (Consolidation) Order 2015, re-made or re-consolidated.
- 3. The Bolton (Shoreswood and Belmont Road) (Temporary Waiting Restrictions) (No.126) Order 2024, shall have the effect as though the sides of lengths of road specified in Part 1 of the Schedule to this Order were deleted from the Schedule to that Order.
- 4. The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, shall have the effect as though the sides of lengths of road specified in Part 2 of the Schedule to this Order were deleted from Schedule 3 to that Order.
- 5. The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, shall have the effect as though the sides of lengths of road specified in Part 3 of the Schedule to this Order were included in Schedule 3 to that Order.
- 6. This Order shall come into operation on the XXX and may be cited as The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015 and The Bolton (Shoreswood and Belmont Road) (Temporary Waiting Restrictions) (No.126) Order 2024 (Astley Bridge Ward Various Streets) (Amendment) (No. XX) Order 2025.
